The Government of Nepal [GoN] has allocated funds towards the cost of Construction of Joroyal ^{rural} Municipality Office Building, Rautkotte, Doti and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Chankotte PHC Building at Joroyal Rural Municipality, "Joroyal, Doti /Goods/EOI-01-074/75", Joroyal Rural Municipality LT line erection works. "Joroyal, Doti /Goods/EOI-02-074/75", Joroyal Rural Municipality LT line erection works at Three Wards (2, 3, 4) "Joroyal, Doti /Goods/EOI-03-074/75", Bidding is open to all eligible Nepalese Bidders.
2. Joroyal Rural Municipality Office, Rautkotte, Doti invites sealed bids from eligible bidders for the construction of Chankotte PHC Building and Electrification work Joroyal Municipality, Doti under National Competitive Bidding procedures.

A complete set of Bidding Documents may be purchased from the Joroyal Municipality Office, Rautkotte Doti by eligible Bidders on the submission of a written application, along with the attested copy of Company/VAT/Fin registration certificate, Tax clearance certificate and upon payment of a non-refundable fee of NRs 3,000.00 till 2074/12/12 within the office hours.

5. Pre-bid meeting shall be held at Joroyal municipality, Rautkotte, Doti on 11:00 hrs.
6. Sealed bids must be submitted to the Joroyal Rural Municipality office, Rautkotte, Doti by hand/courier on or before 12:00 hrs 2074/12/12. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2074/12/12 noon 14:00 hrs the Joroyal Rural Municipality office, Rautkotte, Doti.
The bid security guarantee issued by only the commercial bank approved by Nepal Rastra Bank shall be accepted.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Bidders can bid as a single contractor or in the form of a joint venture of maximum two contracting firms.
10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
